**RAFFLE** - Your contributions will be greatly appreciated. All animals donated must be healthy and a pedigree supplied. An ARBA Judge or Registrar will check the animals for disqualifications. If any are found, they will be noted. Prices of the tickets and drawing time will be posted.

### **SHOW RULES:**

1. This is an ARBA and KSRBA sanctioned show and will be governed by the latest ARBA show rules. Filing of an entry indicates acceptance of these rules. Interpretation of the show rules will be by the show officials.
2. **DAY OF SHOW ENTRY:** \$4.00 per animal Open/Youth for 1 show – OR \$7.00 for 2 shows; \$3.00 Fur and Wool. **\$2.00 PER EAR CHANGE AFTER ENTRY IS ACCEPTED**  
**Make checks payable to SHRBA.** A \$30.00 surcharge will be assessed for a check returned unpaid. Until the check is paid, exhibitor will not be allowed to enter any further SHRBA shows nor be granted their sweepstakes points.
3. Entries taken until 7:30 a.m. (for STARTING BREEDS) and until 8:00 a.m. for all other breeds. The Show Secretary reserves the right to make exceptions.
4. Entry consists of an entry form and comment card(s). Remember the same rabbit cannot be entered in both the Youth and Open Shows. **YOUTH & OPEN ENTRIES MUST USE SEPARATE ENTRY FORMS.** All rabbits/cavies must be entered in the name of the bona fide owner. All fur entries must be entered in the regular class. All exhibitors must fill out ARBA two part comment cards and turn in with their entry. It is the exhibitor's responsibility to pick up their comment cards after judging. These cards will not be mailed.
5. **All entry forms and comment cards must match. ALL CHANGES MUST BE MADE ON THE ENTRY FORM PRIOR TO JUDGING – CHANGES AT THE TABLE ARE NOT VALID.** Per Section 23 of the ARBA Official Show Rules: "...No substitutions, changes, or additions will be allowed in a breed after judging of the breed has commenced." If the comment card and entry sheet do not match, the rabbit/cavy may be given a "no place" award.
6. Owners are responsible for getting their own rabbits to the show table. Carriers are not provided. **ALL RABBITS ENTERED IN THE YOUTH DIVISION MUST BE CARRIED TO THE SHOWTABLE BY A YOUTH. YOUTH ENTRIES HANDLED BY AN ADULT WILL BE TRANSFERRED TO THE OPEN DIVISION.**
7. All rabbits must be permanently and legibly ear marked or they may be disqualified from competition.
8. Any animal showing signs of illness or disease and/or unsightly specimens must be removed from the showroom. Entry fees on such specimens will be forfeited.
9. Neither the Smoky Hill RBA nor the Central Kansas Free (Dickinson County) Fair Grounds will be responsible for any injury or accident occurring during the show. Please understand the below Kansas law before entering, it is also posted in the show room. *KS LAW K.S.A. 60-4001 THROUGH 60-4004*  
*UNDER KANSAS LAW, THERE IS NO LIABILITY FOR AN INJURY TO OR DEATH OF A PARTICIPANT IN DOMESTIC ANIMAL ACTIVITIES RESULTING FROM THE INHERENT RISKS OF DOMESTIC ANIMAL ACTIVITIES, PURSUANT TO SECTIONS 1 THROUGH 4 YOU ARE ASSUMING THE RISK OF PARTICIPATING IN THIS DOMESTIC ANIMAL ACTIVITY.*
10. Parents are responsible for damage done by their children, please keep track of them. Attendees should not enter any other building of the Central Kansas Fair Ground. We will do all within our power to have a safe show, please do the same.
11. SHRBA reserves the right to substitute or add a judge or judges if necessary.
12. To be considered for sanction by SHRBA, there must be a minimum of 10 (ten) animals shown in a breed. Any exhibitor may request and pay for any breed by contacting the Show Secretary. SHRBA retains the right to not sanction any breed.
13. SHRBA reserves the right to refuse entries from any exhibitor(s) placing an entry from all locations within 150 miles which that has had a confirmed outbreak of RCV/RHD/VHD within the past 60 days of the entry deadline and/or date of show.
14. Grooming tables wagons/carts and chairs **MUST NOT** block isles and walkways.
15. Only rabbits and cavies entered in the show are allowed in the building. Sale animals not entered in the show must be kept outside the building. SHRBA does not allow animals under ARBA minimum breed weight in the show barn.
16. **ANY EQUIPMENT AND SALES DISPLAYS MUST HAVE PERMISSION FROM THE SHOW SUPERINTENDENT TO SET UP. A fee of \$10.00 per table or space will be charged.**
17. No Dogs (except those allowed by law), Cats, Scooters, Roller Skates, Skate Boards or Roller Blades allowed in the building.
