This show will be judged in accordance of the ARBA Standard of Perfection.
All fur/wool entries must be shown in a regular class, too.
All rabbits must be permanently and legibly tattooed in their left ear.
The Show Superintendent has the right to remove any animal showing signs of disease.
The Riley County Rabbit Raisers reserve the right to add or substitute a judge as needed.
The Riley County Rabbit Raisers Club is not responsible for any injury or accidents in the show room or on the fairgrounds, with parents responsible for the acts of their children.

Directions to Pottorf Hall at RILEY COUNTY FAIRGROUNDS: I-70 (from east) to K-177 to K-18 (West) or I-70 (from west) to K-18 (East). From K-18 (Fort Riley Boulevard), turn north on Seth Childs (K-13 Exit), then west (left) on Kimball Exit. From north, take Seth Childs (K-13) south, then west (right) on Kimball, Fairgrounds will be on left (south) of Kimball, across from Candlewood Businesses.
